Thank you for requesting a credit application from the Tropicana Las Vegas. Please be advised that our minimum credit issued is \$1,000.00.

Please complete the credit application in full, including your expected date of arrival. All applications are processed according to the expected date of arrival. Without this date, processing of your application could be delayed.

Our credit policy requires that you provide us with an account that has personal or business check writing privileges; that maintains an average balance; has current funding available in the amount of credit you are requesting; and has been open for a period longer than 6 months. You may submit Money Market accounts or Brokerage accounts. However, in addition to this type of account, you must submit a personal checking account maintained in a nationally recognized banking institution. ***Please remember account numbers are required.*** A bank contact is always very helpful in expediting your application.

I agree not to hold any entity responsible or liable for the information released, and further agree not to hold the Tropicana Las Vegas responsible or liable for its use of any such information. I agree that the Tropicana Las Vegas may retain and use the information on this credit application and any information it receives based on my authorization whether or not I am granted credit.

If granted any credit, I agree to sign credit instruments, aka markers or checks (hereinafter "markers") in the amount of funds (e.g. chips, cash, tokens, etc.) issued to me. I further authorize the Tropicana Las Vegas to complete any of the following information on those markers; (1) name of payee, (2) a date, (3) name, account number or address of any of my banks and financial institutions, (4) electronic encoding of the above and (5) any other information authorized by law. The information inserted may be for any account in which I now have, or may in the future obtain, the right to withdraw funds, regardless of whether that account now exists, and whether I provided the information on the account to the Tropicana Las Vegas. I further agree to immediately notify the Tropicana Las Vegas if I am no longer an authorized signatory on any account or if the status of the account has changed in any way. I hereby waive any right to place a stop payment on any marker and further waive any right for presentment of payment. The terms stated in this credit application shall also apply to any personal or business check issued to the Tropicana Las Vegas for payment of any casino debt. **Warning: For the purposes of Nevada law, a credit instrument is identical to a personal check and may be deposited in or presented for payment to a bank or other financial institution on which the credit instrument is drawn. Willfully drawing or passing a credit instrument with the intent to defraud, including knowing that there are insufficient funds in an account upon which it may be drawn, is a crime in the State of Nevada which may result in criminal prosecution in addition to civil proceedings to collect the outstanding debt.**

I acknowledge that irrespective of any gambling, debt collection or currency exchange laws in the country in which I reside, I have the ability and intent to legally pay through my bank or financial institution the funds represented by the markers signed by me, and I hereby waive any such laws that may otherwise prohibit or limit my obligations as provided herein.

I agree that each marker I sign is a separate transaction. If I receive the funds before I execute a marker, I will promptly sign a marker when presented to me, in the amount of the funds I received.

I agree that any funds I place on deposit at the Tropicana Las Vegas may be applied by the Tropicana Las Vegas to any debt owed by me to the Tropicana Las Vegas, and that the proceeds from chips or tokens I redeem may be applied by the Tropicana Las Vegas to any debt owed by me to the Tropicana Las Vegas.

I also agree that any credit granted to me will be used solely for Table Games and Slot Play at the Tropicana Las Vegas and may not be used for Race and Sports and/or Poker play.

I agree that any credit granted to me may be suspended or revoked at any time and without notice by the Tropicana Las Vegas, and I hereby release the Tropicana Las Vegas, including its officers, employees and agents, from any and all claims, damages or losses that I may incur as a result of such credit being suspended or revoked.

I agree that the exclusive jurisdiction for any dispute arising out of or in any way related to any of the above shall be a state or federal court sitting in Clark County, Nevada, and that the laws of the State of Nevada will govern any such dispute. I further that if I do not pay any markers in full when due, that I will pay interest on all such markers at the rate of 18% per annum until paid in full, plus related costs and attorneys' fees incurred by the Tropicana Las Vegas. I understand that the failure to pay a marker is a crime in the state of Nevada which may be subject to criminal prosecution.

I am aware that this application is required to be prepared by the Nevada State Gaming Control Board regulations of the State of Nevada, and I may be subject to civil or criminal liability if any material information provided by me is willfully false.
